If no representations or objections are duly made to the order, or to any part of it, or if any so made are withdrawn, the Oldham Council, instead of submitting the order to the Secretary of State (or part of it if the authority has by notice to the Secretary of State so elected under paragraph 5 of Schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the order (or that part of the order). If the order is submitted to the Secretary of State for Environment, Food and Rural Affairs in whole or in part, any representations or objections which have been duly made and not withdrawn will be sent with it.

The Oldham Borough Council hereby order that:-

- 1. For the purposes of this Order the relevant date is 1st June 2025.
- 2. The Borough of Oldham Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as the Borough of Oldham (Footpath 156 Saddleworth and Bridleway 289 Saddleworth) Definitive Map and Statement Modification Order 2025.
